The goal of our people's noble efforts to build a legal democratic state and a just civil society-muddao is in fact this: to achieve that our tomorrow will be happier and more prosperous than today. The realization of such great and auspicious goals depends on many factors and criteria. But within them, finding justice in our lives is the most necessary condition. In a state where social justice is already ensured, the creative potential, the desire and passion of the people for creativity will be fruitful.

Officials of Public Bodies, Public Associations, enterprises, institutions and organizations are held liable for censorship, obstruction of a journalist's legal activities, violation of his right to inquiry and information, repression of a journalist and interference in his activities. It is impossible to illegally withdraw the material and technical means of the journalist. Insult to honor and dignity of a journalist, threat to his life, health and property, violence or aggression are the reasons for Responsibility in accordance with the law.

State bodies, citizens' self-government bodies, Public Associations, enterprises, institutions, organizations and officials are obliged to provide everyone with the opportunity to familiarize themselves with legislation that is beneficial to their rights and legitimate interests, as well as with documents, decisions and other materials. Access to information is provided by the publication and dissemination of legislation and related materials.

Government bodies, citizens 'self-government bodies, Public Associations, enterprises, institutions, organizations and officials cannot provide information consisting of state secrets or other secrets guarded by law. It can be appealed to the court for actions or inaction of state bodies, citizens 'self-government bodies, Public Associations, enterprises, institutions, organizations and officials that discriminate against citizens' rights to information.

– In our prime, the first place is reflected in the basic rights, freedoms and duties of Man and citizens, and after that, state bodies and their rights and obligations, – says R.Davletov. – The fact that the people are one source of state power, that the most important issues of the life of society and the state are presented to the people's discussion testifies to the responsibility of state bodies to our people.

It is this meaning that is embodied in the content and essence of the reforms carried out by our President Shavkat Mirziyoyev. Every action, opinion and reasoning of the head of our state, especially the words "the people should serve our people, not government agencies," is a vivid practical expression of the rule of Article 2 of our Constitution.

Today, the whole world recognizes that, through the state program "year of dialogue with the people and human interests", adopted and implemented on the basis of the action strategy, these constitutional norms have risen to a new level of quality and efficiency.

The announcement of a new concept of dialogue with the people, the creation of a virtual reception and people's receptions of our president, the introduction of a holistic vertical system for its management, as well as a successful activity that completely changed the worldview of its citizens. All this has become so significant that many scientists and experts argue that this new phenomenon presupposes a revision of the theoretical foundations in the field.

In the system of the Ministry of justice, the protection of human rights is consistently established. Special attention is paid to ensuring that the queue does not wait when our citizens go to these offices, they are served quickly and qualitatively. In this regard, strict tasks are set by the leadership of our state.

Even today, modern mechanisms of dialogue with the people are developing and implementing into society. According to the results of open dialogue with the people and analysis of appeals from individuals and legal entities, projects are being developed to make additional and amendments to the current legislation.
