

## THE ROLE AND SIGNIFICANCE OF NON-GOVERNMENT NON-COMMERCIAL ORGANIZATIONS IN THE DEVELOPMENT OF OUR COUNTRY

### Abstract:

In the reforms taking place in our country, increasing the role of non-governmental non-profit organizations and supporting their participation in the life of society is constantly supported. At the moment, the legal framework for strengthening the legal protection of the activities of non-governmental non-commercial organizations and creating conditions is being strengthened. Also, a number of legal documents have been created to protect and guarantee the activities and interests of non-governmental non-profit organizations.

**Enter** A non-governmental non-profit organization is a self-governing organization established voluntarily by individuals and (or) legal entities, which does not make income (profit) the main goal of its activity and does not distribute the received income (profit) among its participants (members).

Non-governmental non-profit organization protects the rights and legal interests of individuals and legal entities, other democratic values, achieves social, cultural and educational goals, moral and other non-material needs, charitable activities, and other socially beneficial organizations are considered to be organizations.

Non-governmental non-profit organizations are established without personal interests. Non-governmental non-profit organization consists of the English word - non-profit organization, which means an organization whose main purpose of its activity is not to make a profit. In our opinion, such organizations protect citizens' health, satisfy their spiritual and other material needs, as well as develop political, scientific, spiritual-educational and social spheres and is designed to support.

**The main part** Today, there are urgent tasks in the field of social support for the population of our country. In particular, the broad involvement of public control subjects in the implementation of some state tasks, conducting social surveys among the population to study the activities of state bodies and organizations, and establishing an open discussion of identified shortcomings, etc. State grants to increase the effectiveness of civil society, social partnership, and also to develop non-governmental non-profit organizations and doubling the support system through subsidies is the main goal.

In the development of new Uzbekistan, the activities of non-governmental non-commercial organizations and their goals and social initiatives are widely supported. This year, three main innovations have been made regarding the implementation of these issues.

First, regional "Community Funds" were established to support these organizations.

Second, the National Association of Non-Governmental Non-Commercial Organizations of Uzbekistan organized training courses for managers of Non-Governmental Non-Commercial Organizations. The first 50 members of this course studied at the Academy of Public Administration under the President of the Republic of Uzbekistan and were awarded with a special certificate. In the last decrees and decisions adopted by the President of the Republic of Uzbekistan, Sh.M. Mirziyoev, it was established that until 2025, the qualification of 750 employees of non-governmental non-profit organizations will be increased at the State Administration Academy and the volume of state financing of their social projects and programs will be increased by almost 2 times.

Third, non-governmental non-commercial organizations of Uzbekistan state subsidy was allocated to the public support fund and grants were allocated to 120 non-governmental non-

profit organizations that won the competition by the decision of the Independent Council of Experts.

There are also legal bases for the activities of these organizations, which are as follows:

According to the Law of the Republic of Uzbekistan dated April 14, 1994 "On Non-Governmental Non-Commercial Organizations" No. 763-I, their rights and obligations are defined. In particular, in Article 7 of this Law, non-governmental non-commercial organizations have the following rights:

7. represent and protect the rights and legal interests of its members and participants;
8. coming up with initiatives on various issues of social life, making proposals to state authorities and management bodies;
9. participation in the development of decisions of state authorities and management bodies in accordance with the law;
10. dissemination of information about their activities;
11. establishment of mass media and implementation of publishing activities in the prescribed manner;
12. organization of business structures to fulfill the tasks specified in the charter;
13. establish their own symbols;
14. holding meetings, conferences on issues related to their activities;
15. according to the law, opening of representative offices and establishment of branches, etc. are defined.

Article 8 of this Law defines their obligations:

- ✓ compliance with legislation and founding documents;
- ✓ use of their property and funds, including freedom of access to information about sources of financing;
- ✓ to agree on holding events with the registering body (with the exception of political parties) and to allow its representative free access to the events being held;
- ✓ agreeing with the registration body to receive funds and property from foreign countries, international and foreign organizations, citizens of foreign countries or other persons on their behalf;
- ✓ and is obliged to submit reports on its activities to the state statistical authorities in the prescribed manner, etc.

Along with this, other regulatory documents also contain tasks related to the activities of these organizations.

The development of civil society institutions, increasing their social and political activity is defined as the main direction of improving the state and society in the Action Strategy for the five priority areas of development of the Republic of Uzbekistan in 2017-2021. Today, non-governmental non-profit organizations and other institutions of civil society are gaining

importance in the way of establishing a democratic legal state, ensuring the rule of law in society and increasing the socio-political and socio-economic potential of the country.

Also, 2022 of the President of the Republic of Uzbekistan In the Decree No. PF-60 dated January 28 "On the development strategy of New Uzbekistan for 2022-2026", determining the subsidy provided by the public fund for the support of non-governmental non-profit organizations and other institutions of civil society under the Oliy Majlis of the Republic, reducing poverty, important tasks such as creating jobs, introducing the practice of offering the implementation of socially useful projects to non-governmental non-profit organizations on the basis of open competition, and expanding the scope of projects to support the employment of women through vocational training with non-governmental non-profit organizations.

Independent Institute for Monitoring the Formation of Civil Society, "Mahalla", "Nuroni" funds, Youth Movement of Uzbekistan, Council of Farmers, Peasant Farms and Homestead Land Owners of Uzbekistan, "Strategy of Development" Center, "Ezgu Maksad" Foundation, Culture under the Ministry of Culture and arts development funds are important.

It should be noted that it is desirable to develop modern forms of public control, to introduce the practice of checking the quality of execution of regional, branch and state programs based on collective appeals. Also adopted decree and in decisions

1. increase the volume of state support to non-governmental non-profit organizations and other institutions of civil society in the form of subsidies, grants and social orders by 1.8 times in 2025;
2. increase the number of non-governmental non-profit organizations participating in the annual state program announced in the country to 50 in 2025;
3. In 2025, retraining and upgrading the skills of 250 heads of non-governmental non-profit organizations at the State Administration Academy;
4. Important measures have been developed, such as reducing the crimes committed by non-governmental non-commercial organizations by 19.2 percent in 2021-2025.

the President of the Republic of Uzbekistan on March 4, 2021 Decree No. PF-6181 "On the approval of the concept of development of civil society in 2021-2025" developed the annual index of non-governmental non-profit organizations, which was determined to be controlled by the judicial authorities. According to the results of the assessment, the list of "Top 20 most transparent non-governmental non-profit organizations" for 2021 was published.

**Summary** Based on the information given above, we can say that all tasks performed by non-governmental non-profit organizations are aimed at creating a stable environment in the social life of our country, dealing with the problems of the population, and building a strong, developed and prosperous society. In conclusion, it should be noted that it is desirable for the state to support and encourage the work of non-governmental non-profit organizations, increase their work efficiency and further guarantee their rights.
