Violence against women can take many forms and can occur in a number of situations: Women are often victims of rape, which is usually done by men known to them. The level of reporting, prosecution, and conviction for rape varies significantly across different jurisdictions and to some extent reflects society's response to such crimes. This is considered the least reported crime of violence.

After sexual assault, the victim may be raped or threatened with violence, and in many cultures by the victim's own family and relatives. Violence or intimidation of the victim may be committed by the rapist or by the rapist's friends and relatives, preventing the victim from reporting the rape, punishing them for reporting it, or withdrawing the complaint. to take; or may be committed by the victim's relatives as a punishment for causing "embarrassment" to the family.

This is especially true in cultures where women are virgins are highly valued and mandatory before marriage; In extreme cases, the victims of rape are killed intentionally. Victims may also be forced by their families to marry the rapist in order to restore the family's "honor".

Internationally, the number of rapes reported by police in 2008 ranged from 0.1 per 100,000 in Egypt and 91.6 per 100,000 in Lesotho to 4.9 per 10,000 in Lithuania on average.

In some countries, police do not report or accurately record rape because of the consequences for the rape victim and the stigma attached to it.

Domestic rape and domestic violence: Rape in marriage or spouse was once widely approved or ignored by law and is now widely unacceptable violence against women accepted and rejected by international conventions and increasingly prosecuted.

However, in many countries, rape of a spouse remains legal, or is illegal, but is widely tolerated and accepted as a land right. The crime of rape that has taken place in the last few decades. Traditional notions and views of marriage, rape, sexuality, gender roles, and self-determination began to be challenged in many Western countries in the 1960s and 1970s, which has been a family affair for decades. caused the crime of rlash. With a few exceptions, many laws against domestic rape have been passed in the last 30 years. Some countries in the

former communist bloc of Scandinavia and Europe made it illegal to rape a spouse until 1970, but most Western countries only prosecuted him in the 1980s and 1990s. In many parts of the world, anti-rape laws passed in 2000 are very new.

The relationship between some religions (Christianity and Islam) and domestic rape is controversial. The Bible explains in 1 Corinthians 7: 3-5 that there is a "conjugal duty" to have sex with one's spouse (in sharp opposition to it) and that extramarital sex is a sin) and "The wife has no authority over her own body, but the husband has authority.

Also, the husband has no authority over his own body, but the wife. Do not deprive each other ..." Some conservative religious figures call this family explain by denying the possibility of rape. Islam also pays special attention to sexual intercourse in marriage: "The Messenger of Allah (saw) said:" If a husband calls his wife to bed (i.e. to have sex), she refuses and sleeps in anger, the angels will curse her. . until morning '; "and several comments on the issue of rape in marriage have been criticized by Muslim religious leaders.
