Subjects who partially specialize in promoting deviant behavior among adolescents, preventing various violations between them include Social Services, Education, Youth, health



institutions, as well as nature protection, control-inspection and counseling, coworking organizations. Law enforcement agencies are specialized subjects of prevention of huqubuzarism among adolescents. They carry out direct educational and preventive work with delinquent adolescents. These are the court, the prosecutor's office, the internal affairs, the justice authorities and other institutions.

In working with adolescents, citizens' self-government bodies, NGOs, family and a number of other institutions of civil society are also actively engaged. Because these organizations carry out comprehensive, programmatic work on the involvement of the public in the work with minors, as well as on assisting state bodies in this regard. They are considered interested in preventing cases of various violations and conduct of misconduct among minors.

The large-scale reforms consistently implemented under the leadership of the field of education are aimed at further development of the country, increasing the spirituality of young people, realizing their noble aspirations and hopes, educating young men and girls in nothing and no one inferior personalities.
