Most decisions are made by men, who dominate political structures.

Since the first years of independence, Uzbekistan has been systematically implementing measures to improve the status of women and achieve gender equality. The experience of Uzbekistan in ensuring the rights and freedoms of women in the framework of the implementation of the Agenda for Sustainable Development for the period up to 2030 has been distributed among the UN member states as an official document of the 75th session of the UN General Assembly. At the same time, experts of the UN and the Inter-Parliamentary Union (IPU) emphasize that the trends observed in Uzbekistan in this area are in line with the global processes of

According to the IPU's annual women in parliament report and UN Women's data, for the first time in January 2021, the global proportion of women in national parliaments was more than a quarter – 25.5%. According to the results of the parliamentary elections at the end of 2019, they amounted to 32% of the deputies of the Legislative Chamber of the Oliy Majlis, 25% in the Senate. According to this indicator, Uzbekistan entered the top 50 countries (out of 190), ahead of almost all post-Soviet countries. This indicates fundamentally new approaches and trends in the organization of the activities of the Uzbek parliament. [2]
