

## IMPORTANCE OF MIXED SPORTS CONTRACTS IN THE DEVELOPMENT OF THE SPORTS INDUSTRY (THESIS)

**Abstract:** Today, many in developed or developing countries are engaged in sports. Sports events and various competitions are organized around the world. As a result, in the next two years, the number of people constantly involved in sports in our country doubled."<sup>1</sup> Indeed, the emphasis on sports at the government level should be acknowledged today. To develop the opportunities, conditions, but in order to develop any industry, it is necessary to carefully study each related process, create and strengthen the legal basis for sports law that is developing in our country as a lawyer. One of the fundamentals of ensuring the integrity, transparency and fairness of the sports industry is the integrity of sports law. (Matthew 24:14; 28:19, 20) Today, the process of creating its legal foundations is under development.

If we stop sports contracts that are part of the right to sport in their place, these agreements are divided into three types:

Civil sports contracts.

Labor sports contracts.

Mixed sports contracts.

From the foregoing, when it comes to mixed sports contracts, these types of contracts specify both civil legal relationships and employment legal relationships. At the same time, when concluding contracts, it is necessary to thoroughly study the relationships regulated by policy-making documents.

First of all, in accordance with Article 16 of the United Nations Convention on the Elimination of All Forms of Discrimination against Women, physical education and sports organizations Individual entrepreneurs working in physical education and sports organize work on the development of physical education and sports among different groups of people to prepare, protect and strengthen athletes and other professionals participating in sports events and training events creates conditions, provides athletes and trainers with the necessary conditions for training, and helps these professionals in

a different way to achieve sporting results. Based on this standard, we may learn the scope of subjects of mixed sports contracts, including : Individual entrepreneurs, athletes, trainers, judges, and individual entrepreneurs working in physical education and sports other persons. The procedure, form, requirements for them, rights and obligations of the parties in mixed sports contracts signed within the framework of these entities and the basics of their implementation will be brought forward. In accordance with Article 42 of the Aforementioned Republic of Uzbekistan Act, we read : "The relationship between institutions and organizations with unmarried athletes In accordance with the established procedure, only with the consent and participation of their parents or surrogates or specialized institutions where they are raised ", they emphasize. It is understood from this standard that so far, the rights and obligations of unmarried athletes have not been determined by our nationality, even in mixed sports contracts.

If we also talk about the order in which a mixed sports contract is concluded, the form, the requirements for them, the rights and obligations of the parties, and the basis for their implementation, these are regulated by the Civil Code and the Employment Code in our nationality. However, the issues of responsibility for disputes arising from mixed sports contracts, whether by these standards or by other standards, have not yet been fully covered. This does not cite the procedures and procedures for reviewing disputes that arise on the surface in sports.

Representatives of the industry who work in the sports industry have also been open to the issue of their salaries in contracting, namely, athletes in mixed sports contracts with professional athletes. The minimum wage specified for a normal life is not in any of our policy-making documents in our nationality. Because in the sports industry, as we have noted above, contractual legal relationships can benefit the catalogue. That is, whether it's football, basketball or baseball, sporting and achieving starchy in a renowned team can bring a great deal of income.
